## In the spotlight: our new report

## Making better use of data: identifying customers in vulnerable situations

On 26 October, Ofwat and Ofgem, through the UK Regulators Network (UKRN), published their report: <u>Making better use of</u> <u>data: identifying customers in vulnerable</u> <u>situations</u>. In this report we:

- Highlight positive collaboration already taking place between water and energy companies to better identify customers who might be in a vulnerable situation.
- Explore how companies can make better use of data and work towards sharing non-financial vulnerability data across sectors
- Set expectations for companies on how we'd like to see them move forward with this work and how we as regulators will contribute to and monitor developments.


Vulnerability is an issue that shows no sign of abating and we think there is scope for water and energy to work more closely together, pooling their knowledge and insight, to better support customers. Energy and water companies have already collaborated to <u>signpost</u> one another's support services for customers. We want them to go further.

In this report, we have set out our expectations for both sectors, to work towards cross-sector sharing of non financial vulnerability data.

We present principles to help companies move towards data sharing based on building customer confidence and effective company collaboration.

Building on the energy sector's Safeguarding Customers Working Group, Water UK and the Energy Networks Association have established a joint working group to take forward cross-sector data sharing. Both water companies and energy network operators are participating in the group. Two of the companies (United Utilities and Electricity North-West) will also be launching a pilot vulnerability data-sharing programme in their region using live customer data in January 2018. Both regulators strongly support the establishment of the joint working group, and can see real benefit in the pilot initiative. The working group will report on their progress on a quarterly basis from January 2018. Ofwat and Ofgem, through the UKRN, are also committing today to publish a follow-up paper with updates on company progress in autumn 2018.

#### 60 seconds with Ben Haden

Meet Ben, the UKRN's Ofgem Principal, who talks about collaborating with colleagues across Ofgem and the UKRN networks, learning to climb and visiting Russia.

#### What is your role at the UKRN? Tell us a bit about it...

I'm Ofgem's principal rep. This mainly involves helping colleagues in Ofgem get in touch with other regulators via the UKRN network, and pointing other regulators towards the right people in Ofgem when they have a question or idea. I also brief Martin Crouch and Dermot Nolan for their meetings as Senior Rep and CEO, ensuring they have the information they need on our involvement with UKRN.

## What are the highlights and challenges of being a Principal?

The highlight is definitely the opportunity to talk to different teams around Ofgem, hear about what they are working on and then identify how the UKRN network can help them. I'd say the biggest challenge is keeping track of all the different UKRN projects or working groups Ofgem is involved with, because there are so many!

## What sort of work do you do outside of the UKRN?

I work in Ofgem's 'Decision Support' team, which aims to improve the way



we make regulatory decisions. This includes tracking upcoming decisions so that our Board, GEMA, knows what is coming in advance and can be confident that an appropriate process has been followed. We also provide monthly summaries of external trends to the board, to give them context for decision making. Lately, we've also been closely involved in reforming the way our internal boards work.

## If I bumped into you in the kitchen, what should I ask you?

Climbing. I've been learning with a group of friends for the last few months and am gradually overcoming my semifear of heights. There are a lot of experts who also work at Ofgem, so I benefit from a lot of tea-room advice.

## And finally, what country would you love to visit and why?

Russia – I've been twice before but can't get enough. I'd love to go in winter and contrast it to my previous summer trips.
