Bill Emery, UKRN Chair of Chairs

Earlier this year I was privileged to take over from Jonson Cox as "Chair of Chairs" of UKRN. This is an informal role chairing the regular meetings of the Chairs' Group and assisting with UKRN governance, Strategy and Expert Panel. Our members oversee and regulate huge swathes of the UK economy and it is clear we all gain hugely from the work we do collectively.

Many of you will be familiar with me through my 30 years in regulation including at Ofwat, ORR and now as Chair of the Northern Ireland Utility Regulator. I am also Chair of CERRE, a Brussels-based think tank dedicated to ever better regulation for the energy, tech, media, telecom, mobility and water sectors. "Ever better" is a mantra that is relevant to our work as regulators and for the sectors we regulate. We can achieve this by learning from others, sharing knowledge and experiences, and testing and

taking opportunities as they arise. This is at the heart of UKRN.

It's been a really busy time and I wanted to share some of the highlights from the many UKRN meetings and activities I've been involved in:

- at our April Chairs group, we discussed appointments to regulatory boards with Peter Riddell – the public appointments commissioner.
- in July we met senior officials of the Cabinet Office to discuss developing plans for better regulatory and other opportunities. And
- at our meeting in November, we are exploring Net Zero strategy and implications

I have found the discussions at our Expert Panel meetings in June and September to be exceptionally interesting. We have had wide ranging, informed, insightful and thought-provoking debates on four topics: climate change & vulnerability, vulnerability and data, outcomes and measurement and regulatory appeals. Colleagues from our relevant working groups were involved in these meetings to take forward the learning into our work programmes. The panel also had an introductory session with the CEOs group a few weeks ago. Overall, it has been a hugely impressive start for our new panel and I thank Cloda, Helen, Mick and Suzanne for their very positive contributions so far – the future looks a little less daunting for us with their help! I encourage all our network members to use the panel to assist them – talk to Barbara on how to do this.

Finally, a big thank you to Attricia and the team at UKRN for the work they are doing. We have an important work programme to deliver to make a difference. We are living through very challenging times but with the collaboration, mutual support and encouragement through our network we will be better able to meet the challenges ahead.

Cloda Jenkins, Expert Panel member

Back in 1997 when I started working as an economic advisor in the regulated sectors, I never imagined I would get to a point where I would be able to discuss pressing issues with, and learn from, dedicated staff across the regulators. It has been a privilege to join the Expert Panel at a time of challenge and ambition across all the sectors that UKRN represents. I was involved with early versions of the Joint Regulators Working Group and can see the original rationale for coming together, to allow for the

value of economies of scale and scope in ideas and experiences to be explored, remains strong. Now, it is backed up by an impressive small group of dedicated UKRN staff and a network of working groups seeking solutions to significant problems that affect us all.

In my career I have focused on the nuts and bolts of incentive regulation, working across sectors, and it is great to see that improving incentives, to deliver cost efficiency, innovation, quality of service and environmental improvement has not lost its place at the regulators' table. The details and priorities always change but the need to maintain well known principles of incentive regulation and to remember lessons from history and from across sectors does not go away.

What I have valued most from being on the Expert Panel is the opportunity to take a broader look at regulation. It has been particularly humbling to talk to my colleagues on the Expert Panel and several UKRN members about how to improve efficiency of outcomes and equity of outcomes in parallel. Most of our discussions to-date have inevitably led us to the challenges of how to support vulnerable consumers, particularly in the context of the Covid pandemic, and how to meet the inter-generational objective of a fair transition to net zero.

Regulators have learnt from each other about the technical detail and processes of price controls, and mechanisms to enhance market competition, for some time. Now we are not just thinking about common cross-sectoral issues but issues that sit above each sector and require true collaboration of ideas for us to be in with a fighting chance of delivering the step-change needed. The UKRN work programme provides a great basis to get the conversations going and I look forward to working with all those involved to turn ideas into practical solutions that we see implemented across the sectors.

Vulnerability network update

Since April, UKRN's Vulnerability network has organised and facilitated many roundtables, including the impact of Covid on vulnerable consumers and data recording of vulnerability. These sessions have already led to some interesting next steps that will feature in the 2022 workplan.

The final roundtables of 2021, covering debt and affordability, took place in October and included speakers from a range of external organisations and government.

- Better Regulation: and
- Government Data Strategy

Reflections on Covid

On 17th June UKRN hosted a roundtable discussion for members, government departments, consumer groups and trade associations, "Reflections on responding to the impact of Covid and the way forward: A regulatory perspective." The event provided the opportunity to take a step back and reflect collectively on the experiences and learnings of the last 18 months, and to look ahead to consider what this means for the future. A range of speakers from our members and industry gave great insight into how the sectors responded to the challenges. Learnings included:

- Future focus on consumers in debt, and affordability, with the lasting impact of Covid
- Retain responsiveness to industry, essential for sectors to remain competitive

- Use of data, and data driven solutions, across sectors where possible
- Continue to listen, learn and adapt to consumer needs: enable innovation

With the furlough scheme due to finish in September 2021, UKRN has partnered with WIG to discuss how this picture may develop, the role of key stakeholders across the sectors in supporting vulnerable households and those consumers who maybe new to debt, and how consumer debt levels may influence wider economic recovery.
