FEATURE: Next Generation Non-Executive Director (NED) scheme



Our Next Generation NED scheme was set up four years ago, by Fiona Lennox at Ofcom. In September this year, Fiona made the decision to step away from the scheme. She has been a powerhouse of energy, knowledge, enthusiasm, and ambition, and will be greatly missed by the

delivery team. We are forever grateful to Fiona for her leadership in getting the scheme up and running, as well as driving it forward for three successful years.

"Next Gen NEDs has been a passion for me these last few years. Together we have created a unique range of opportunities for our colleagues. We've started to see successes from that and I hope the initiative will continue enabling more colleagues to begin their journeys of applying their amazing range of talents in wider public service.

With Fiona stepping back, UKRN has taken ownership of all elements of the Next Generation NEDs scheme, including our LinkedIn group and Community of Interest, as well as the flagship 12-month placement programme, which offers placements across UKRN members on boards, panels and committees, with a Non-Executive Director mentor. We are also in the process of establishing an alumni group, harnessing the experiences of the previous NED participants to raise the profile of the scheme and help us improve it further for future cohorts.

Now in its fourth year, we have welcomed FCA to the placement programme and are also running a pilot year with SSRO, which brings the total number of participating members to 7, with 17 placements on offer. The scheme continues to grow in popularity, with over 500 people now part of our Community of Interest, and we have now put in place a schedule of 'Spotlight' events, sharing insights from and about NED roles, every 6-8 weeks.

EVENTS: RECENT AND UPCOMING

Regulating for Resilience: a whole of society approach

On 26 September, we held an <u>event at Ofcom</u> looking at the 'whole of society' approach to resilience, identified through our joint workshop with the Whitehall & Industry Group in <u>June 2023</u>.

This brought together representatives from the <u>Cabinet Office Resilience</u> <u>Directorate</u>, the <u>National Preparedness Commission</u> and the <u>National Infrastructure Commission</u> alongside our regulator members, to explore current measures and initiatives in resilience.



Sessions included a focus on resilience standards, practical insights from regulators on the operational aspects of resilience and how best to facilitate collaboration for a cross-sectoral approach.

The event was very well-received, with lots of positive feedback from attendees and members as we work towards delivering on our strategic objective of Supporting Sustainable Economic Growth and Resilience.

Growth Duty framework – working group

Over the past few months, UKRN has hosted a series of Working Group meetings for members to discuss approaches to reporting under the <u>Growth Duty performance framework</u>. This was an opportunity for relevant members to get together, discuss and share their learnings on how best to submit their first report on how they are meeting the Government's <u>Growth Duty</u>, which was recently extended to include Ofcom, Ofgem and Ofwat. A further Working Group meeting is scheduled for November following the initial submission, and UKRN continue to engage with the Department of Business and Trade on next steps for the performance framework.

As part of our Next Generation NED scheme, we have the next in our series of 'spotlight' sessions to be delivered to our Community of Interest.
