FEATURE: David Black – the (half-)year in review

I was delighted to be asked to take over as CEO of UKRN over the summer. This is a particularly exciting time for UKRN, as the new government's agenda focused on growth and investment aligns particularly well with key areas of UKRN activity.

Over the past few months, UKRN has made sure that regulators are at the heart of policy discussions on growth and investment, through member workshops on the Growth Duty Performance Framework, our fantastic resilience event

with the NIC and Cabinet Office or the latest update to our Cost of Capital report.

There has also been progress with other elements of UKRN's Strategy – for example, on vulnerability we have been working closely with DBT on the planned rollout of a Shared Support Register, which is likely to continue to be important given cost of living pressures, while on climate change we continue to work with DESNZ on the Net Zero Regulators-Government forum.

Looking ahead to 2025, I expect to see UKRN continuing to remain agile and responding to the needs of its members and supporting them in their engagement with the government. I would also like to see UKRN supporting a productive dialogue with the investor community, and I know there are some exciting plans in that area. Finally, I look forward to UKRN's conference next year, where we will be able to talk about all these issues and more!


Excellence through collaboration

FEATURE: Claire Simpson, former UKRN Director

Claire, who is currently a Senior Policy Manager at the PSR, was UKRN Director from Oct 2015 to Jan 2017.

What made you apply for a role at UKRN originally?

I loved the idea of working on cross-regulator projects, understanding how we can collaborate more, particularly where we shared the same outcomes such as consumer vulnerability.



What did you enjoy most about working at UKRN and why?

I enjoyed getting out and about! It was before we were all on Teams...so it involved a lot of visits to different teams and external stakeholders, from central government to investors. Seeing people from across regulators extend their own relationships and networks was very rewarding.

How did your experience working at UKRN support your career?

Working at UKRN gave me a much wider perspective and a good strategic understanding of regulation across different markets, I built my own network, and I was able to develop my leadership skills. I left to have my first baby, which had a different set of challenges...!

How have you seen UKRN change in the time since you left the team?

It's so great to see UKRN still going strong and still growing! Some of the staff-focussed initiatives are seriously impressive. UKRN is well recognised with stakeholders and every time someone mentions it I still feel very proud to have been a part of it.

What would you like to see in the future for UKRN?

To continue to strike the right balance between collaboration on policy and networks for people to learn and build relationships.

FEATURE: Joe Duffield, former UKRN Vulnerability lead

Joe, who is now a Managing Consultant at Capgemini Invent, reflects on his time as Head of Vulnerability at UKRN (Jun 2019 to Oct 2020).

What made you apply for a role at UKRN?

After 5 years working in Competition Policy at Ofcom, I was eager to do something with a more direct impact on citizens and consumers. I had been aware of the UKRN and its work since starting at Ofcom and jumped at the chance to get involved in its vulnerability programme.



What did you enjoy most about working at UKRN, and why?

It's extremely cliche, but the people. It was really energising and rewarding to engage with colleagues from different organisations and backgrounds; from third-sector vulnerability specialists to senior corporate stakeholders. I also hugely enjoyed the relationships I built within the UKRN team itself (shout out to the fantastic Kev Smith!).

How did your experience working at UKRN support your career?

In my case, extremely directly – it was while speaking on a panel at a vulnerability event that I met my current employer. This was a great example of the exposure and platform that working at UKRN gave me, as well as preparing me to drive work forwards and learning how to take people with you. This also involved a lot of negotiating, as well as chances to showcase innovation and initiative.

How have you seen UKRN change in the time since you left the team?

Over the past couple of years, despite huge pressures and challenges, UKRN has really gone from strength to strength. I've been so impressed with what this small team has been able to achieve and the work it's done to push cross-sector collaboration.

What would you like to see in the future for UKRN?

The UKRN's purpose is now perhaps more important than ever, as challenges bleed from one regulated sector in another. The idea that the individual regulators can solve such challenges on their own is at worst, naive, and at best, inefficient. I'd like to see a much more central role for UKRN, where it can be relied on more readily when it comes to regulators addressing issues, particularly concerning the ever-growing issues relating to consumers in vulnerable circumstances.
